For instance, to meet new governmental regulations:

- FltPlan.com was the first to offer certified eAPIS manifest submission for the new Customs and Border Patrol requirements (see http://www.fltplan.com/eAPISinfo.htm).
- FltPlan.com was the first to provide an FAA approved method of checking GPS RAIM prediction integrated with your flight plans, to meet the new FAA requirements for flights predicated on GPS (see http://www.fltplan.com/GPSRAIMpredictioninfo.htm).

Some other improvements we made this year include the following:

- You can now create and file flight plans to/from Bermuda, the Virgin Islands, Alaska, Hawaii and Puerto Rico using FltPlan.com.
- You can now create and file VFR flight plans on FltPlan.com, using all the ease and reliability you've come to count on for IFR flight plans.
- We added features for your smartphones, such as Approach charts and the Airport/Facility Directory.
- You can now upload your FltPlan.com flight plan data to your Honeywell AFIS, Rockwell Collins RIU-4000, Teledyne Controls Telelink, and Universal Avionics Unilink systems, using Satcom Direct datalink.
- You can also now upload FltPlan.com flight plan data to your Garmin 1000 system or Garmin 430W/530W system.
- You're able to retrieve flight plan information for flights filed on FltPlan.com from as far back as 2005. (This feature can be found on our Flight Tracking page.)
- When copying aircraft performance from a donor, you now have the option to include the ICAO Format equipment data. This is perfect for

transferring a 'customized' aircraft to a new member of a flight department, or to transfer your customized performance and ICAO Format data to a buddy that flies the same make and model of aircraft.
