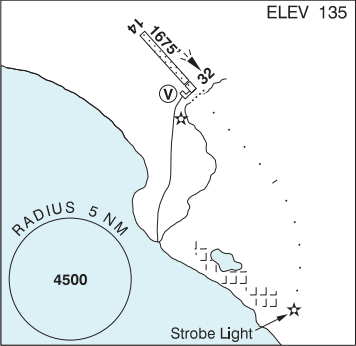

PRO	Crews must be familiar with A/D environment due surrounding precipitous terrain & variable lcl cond. Apch Rwy 32: Intercept apch lighting at hdg 009°T, curve left to rwy hdg 318°T. If ldg not assured by overshoot bar (1000' fr thld), immediately climb left turn to hdg 187°T. Acft must park SE side of apron, close to tml bldg, at least 60m fr rwy centerline to remain outside rwy strip.	
CAUTION	Rwy edge lgt installed higher than std (aprx 27 inches high loc 5' outside rwy edge). Possible low-level wind shear with N and W winds. Extv migratory bird activity May-Oct.
